- Mayor Lory Patteri read the script for the Public Hearing.
- Jamie Batchelor, Town Planner (J.L. Richards) reviewed the application being an application to vary the provisions of Section 6.2 to permit a reduced rear setback of ± 6.2 meters from a required setback of 7.5 meters. Furthermore, that the applicant is seeking a Minor Variance to permit the construction of a single detached dwelling with an attached carport. The Planner's Report was reviewed in its entirety with the Committee. Mr. Batchelor concluded that "based on our professional assessment, the proposed main residential dwelling consisting of a single detached dwelling unit and an attached carport meets the intent of Section 6.2 of the Zoning Bylaw".
- The Applicant, John Atkins, spoke briefly about the application and his agreement with the Planner's Report.
- No written submissions relating to this application were received by the Municipal Administrator.
- Randy Polischuk, of 46 Prout Street, attended in person and stated that he was against the Minor Variance and that the Variance should have been dealt with before the work commenced at the site. Mr. Polischuk stated he did not like the building proposed as it is "crooked" on the lot. Mr. Polischuk was adverse to the use of the Minor Variance provision for any property.
- Joe Murschitz, of 27 Crawford Street, attended in person and stated that he was against the Minor Variance because the house was on a slant on the property and not desirable for the neighbourhood. Mr. Murschitz presented pictures of a fencing issue which did not address the Minor Variance.
- Conrad Leach, of 29 Crawford Street, attended in person and stated that he was against the Minor Variance because, in his opinion, it was not minor. Mr. Leach did not agree with the use of the Minor Variance and stated that the setback was 7.5m and no deviation should be allowed. Mr. Leach also stated that the house was, in his opinion, not desirable due to the angle it was being placed on, on the lot.
- Committee member Mariola Morin questioned the need for the proposed building being on a slant on the lot. Ms. Morin expressed concern over the "look" of the neighbourhood if property owners were allowed to place their houses on the lot according to their own preferences.
- Committee member Shane Rock expressed concern over the placement of the building on the lot as well and stated his further concern as to whether or not the building could be repositioned in such a manner that a Minor Variance would not be required. Mr. Rock questioned the Town Planner on the issue of what is considered "minor".
- Committee member Jody Orto questioned the need for the building being on a slant and the need for a Minor Variance if the structure were positioned differently.

- Mr. Batchelor re-stated that the requirement for a Minor Variance was that the application meet the 4 tests: a) Is the application Minor in nature, b) Is the request desirable for the appropriate development or use of the land, building or structure, c) How does the request maintain the intent and purpose of the Official Plan, and d) How does the request maintain the intent and purpose of the Zoning Bylaw?
- Mr. Batchelor stated that, in his professional opinion, the application did meet the intent of Section 6.2 of the Zoning Bylaw and recommended the Minor Variance be granted.
- Mayor Lory Patteri also agreed with Mr. Batchelor that in her opinion that the application met the 4-test requirement for the granting of a Minor Variance. Mayor Patteri was not concerned with the positioning of the building on a slant on the property and did not feel that this was an issue appropriate for denying the application.

- Angelo Maione addressed council in that on November 15, 2023 a pre-consultation meeting was held for a building permit for 9 Mitchell Street. Town Planner informed applicant, only a Minor Variance was required. February 7, 2024 applicant was informed of the Site Plan Control application. Mr. Maione states that it is critical to provide applicants with a project specific list of requirements in writing.
- Mr. Maione stated the planning process was mishandled from the beginning and was asking council to vote to omit the Site Control application as long as the applicant provides a drainage plan and retaining wall plan to be inspected by the building inspector.
- Mr. Maione asked the Planner, Jamie Batchelor (who was present via Zoom) why the Site Plan Control Bylaw (2009-35) had not been brought to his attention until February 7, 2024.
- Mr. Batchelor stated that the Site Plan Control Bylaw was not readily available on the Town's website and that it's existence was unknown until the Municipal Administrator was asked specifically if the Town had such a Bylaw.
- The Municipal Administrator, Ms. Davis, agreed that the Bylaw was not made known to the Planner until February, 2024.

- Ms. Davis also commented that the Bylaw, whether it is November 2023 or February 2024, contains provisions necessary for the proper planning of the Town's development and that the regulations concerning, for example, drainage, accessory buildings, retaining walls, parking and vegetation could not simply be dismissed. Ms. Davis gave the Planning Act and Build Code as examples of legislation which could not be "waived" and neither should the Site Plan Control.
- Councillor Rock asked Mr. Maione if the issue with having to apply for a Site Plan Control was a financial one. Mr. Maione stated that it was not and that the fee was not an issue.
