- Due to the new regulations under PS3280 (Asset Retirement Obligations) regarding the landfill, the liability for the closure of the operational sites and post-closure care have been recognized. The expected closure of the landfill is 2045, with a post closure monitoring to be incurred through to 2069.
- Mr. Marinovich commented that it was a clean audit with no outstanding issues or concerns.
- Investing a portion of the Town's reserves into a higher interest bearing account was discussed. The total reserves, cash and cash equivalents reported by the Town are sufficient to allow for further investing. Council directed the Treasurer to look into this further.
